

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to all those who use our services and platforms (“users”), and D’s Ventures, LLC, and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to D’s Ventures, LLC, include its DBA of Logmet Solutions, and www.logmetsolutions.com (“website”). By using the D’s Ventures, LLC, website, you consent to the data practices described in this statement. This Privacy Policy should be read together with our Terms and Conditions which is hereby incorporated by reference.

1. Collection of your Personal Information

In order to better provide you with products and services offered, D’s Ventures, LLC may collect personally identifiable information, such as your:

- First and Last Name;
- Age;
- Mailing Address;
- E-mail Address;
- Phone Number; and
- Online Payment and Banking Information.

Non-Personal Data. Non-personal data includes any data that cannot be used on its own to identify, trace, or identify a person. We may collect your IP Address, device information, or location information. When non-Personal Data you give to us is combined with Personal Data we collect about you, it will be treated as Personal Data and we will only use it in accordance with this Privacy Policy.

If you purchase D’s Ventures, LLC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We collect and use your Personal Data for the following reasons:

- To verify your age, identity, and location to ensure your eligibility to use the Services;
- When it is necessary for the general functioning of the Services, including the assistance of payments
- When it is necessary in connection with any contract you have entered into with us (including our terms of service or when you make a purchase through the site) or to take steps prior to entering into a contract with us;
- When we have obtained your or a third party’s prior consent to the use, including to communicate with you about our Terms and Conditions, updated features, and upcoming events;
- When we have a legitimate interest in processing your information for the purpose of providing or improving our Services;
- When we have a legitimate interest in using the information for the purpose of contacting you, subject to compliance with applicable law; or

- When we have a legitimate interest in using the information for the purpose of detecting, and protecting against, breaches of our policies and applicable laws.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through D's Ventures, LLC, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) signing up for special offers from selected third parties; (c) sending us an email message; (d) submitting your credit card or other payment information when ordering and purchasing services. D's Ventures, LLC will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

We will only retain your Personal Data for as long as is necessary to fulfil the purposes for which it is collected. This length of time may vary according to the nature of your relationship with us. Personal Data will be purged after five years of nonuse of an account

2. Use of your Personal Information

D's Ventures, LLC collects and uses your personal information to operate and deliver the services you have requested.

D's Ventures, LLC may also use your personally identifiable information to inform you of other products or services available from D's Ventures, LLC and its affiliates.

If you comment or upload images or post content to the Services, we may publish the information below. Unless you disclose personal information within these data points, other users are unable to directly identify the name of the account owner.

- Username;
- Name; and
- Profile photos.

3. Sharing Information with Third Parties

D's Ventures, LLC does not sell, rent or lease its customer lists to third parties.

D's Ventures, LLC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to D's Ventures, LLC, and they are required to maintain the confidentiality of your information.

D's Ventures, LLC may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on D's Ventures, LLC or the site; (b) protect and defend

the rights or property of D's Ventures, LLC; and/or (c) act under exigent circumstances to protect the personal safety of users of D's Ventures, LLC, or the public.

4. Affiliates and Subsidiaries.

We may, for our legitimate interests, share your information with entities under common ownership or control with us who will process your information in a manner consistent with this Privacy Policy and subject to appropriate safeguards.

5. Successors in Interest.

We may, for our legitimate interests, share your information with a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, in which Personal Data about our Users is among the assets transferred. You will be notified of any such change by a prominent notice displayed on our Services or by e-mail. Any successor in interest to this Privacy Policy will be bound to the Privacy Policy at the time of transfer.

6. Law enforcement and other governmental agencies.

We may share your information when we believe in good faith that such sharing is reasonably necessary to investigate, prevent, or take action regarding possible illegal activities or to comply with legal process. This may involve the sharing of your information with law enforcement, government agencies, courts, and/or other organizations.

7. Service Providers.

D's Ventures, LLC may share information with contractors, service providers, and other third parties we use to support our business and who are bound by contractual obligations to keep your Personal Data confidential and use it only for the purposes for which we disclose it to them.

8. Tracking User Behavior

D's Ventures, LLC may keep track of the websites and pages our users visit within D's Ventures, LLC, in order to determine what D's Ventures, LLC services are the most popular. This data is used to deliver customized content and advertising within D's Ventures, LLC to customers whose behavior indicates that they are interested in a particular subject area.

9. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by D's Ventures, LLC. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the D's Ventures, LLC website.

10. Use of Cookies

The D's Ventures, LLC website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize D's Ventures, LLC pages, or register with D's Ventures, LLC site or services, a cookie helps D's Ventures, LLC to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same D's Ventures, LLC website, the information you previously provided can be retrieved, so you can easily use the D's Ventures, LLC features that you customized.

12. Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records; and
- Direct any service providers to delete your personal information from their records.

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to:

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;

- Comply with the laws of Georgia or other applicable jurisdictions;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

13. Children Under Thirteen

D's Ventures, LLC is intended for users over the age of 18. D's Ventures, LLC does not knowingly collect personally identifiable information from children under the age of thirteen.

14. Changes to this Statement

D's Ventures, LLC reserves the right to change this Privacy Policy from time to time. We will notify you about significant changes in the way we treat personal information by sending a notice to the primary email address specified in your account, by placing a prominent notice on our website, and/or by updating any privacy information. Your continued use of the website and/or Services available after such modifications will constitute your: (a) acknowledgment of the modified Privacy Policy; and (b) agreement to abide and be bound by that Policy.
